

PLQ Chinese New Year 2020 Campaign Terms & Conditions

1. Abundance Packets: Red Packets Redemption

3 January – 24 January 2020 (both dates inclusive)

- a. Shoppers are eligible to redeem an intricately-designed 8-piece pack of red packets with every S\$38 spend in a single same-day receipt at any stores, from 3 January– 24 January 2020.
- b. Redemption is on a first-come first-served basis, while stocks last.
- c. Redemption must be made on the same day as purchase. Limited to three (3) redemptions per shopper per day. Redemption is available at the B1 Concierge Desk from 3 January – 24 January 2020.
- d. Spend receipt(s) used for participation in the Promotion must be of purchases made by the shopper personally, and of minimum S\$10 in nett value each.
- e. Shopper must be physically present at the time of redemption, must provide a mobile number (or flash the unique QR ID from Lendlease Plus member's mobile app) and show an original proof of purchase to be eligible for the redemption.
- f. The management will not replace any redemption items in any case of loss, theft or damage.
- g. Gifts accorded cannot be transferred, exchanged for cash or kind and extended beyond its expiry. Shoppers are responsible for checking the redemption items before leaving the counter, and strictly no exchange will be allowed upon leaving the Concierge Desk.
- h. All redemptions are further subject to the General Terms and Conditions as set out below.

2. Rewarding Shopping: Lendlease Vouchers Redemption

3 January – 24 January 2020 (both dates inclusive)

- a. Shoppers are eligible to redeem
 - a S\$5 Lendlease Voucher with minimum spend of S\$68 (S\$58 for Lendlease Plus members) at any stores, within a maximum of three (3) same-day receipts, from 3 January – 24 January 2020.

OR

- a S\$10 Lendlease Voucher with minimum spend of \$108 (S\$98 for Lendlease Plus members) at any stores, within a maximum of three (3) same-day receipts, from 3 January – 24 January 2020.
- b. A total of 150 sets of S\$5 Lendlease Vouchers and 150 sets of S\$10 Lendlease Vouchers are available for redemption per day. Limited to one (1) redemption per shopper per day, per voucher type.
- c. Redemption is on a first-come first-served basis, and while stocks last.
- d. Redemption must be made on the same day as purchase. Redemption is available at the B1 Concierge Desk from 3 January – 24 January 2020.
- e. Spend receipt(s) used for participation in the Promotion must be of purchases made by the shopper personally, and of minimum S\$10 in nett value each.

3. Shop To The Top

3 January – 9 February 2020 (both dates inclusive)

- a. The top 3 spenders every week will be awarded with \$200 worth of Lendlease vouchers each.
- b. Shoppers' spend value shall be calculated based on the following: Subject to the General Terms and Conditions set out below, every nett dollar spent at non-fashion stores will contribute towards shopper's total spend in its equivalent value. Every nett dollar spent at fashion stores will contribute towards shopper's total spend worth 5 times its value.

- e. Plus\$ awarded to Lendlease Plus members for spend amounts remain subjected to the standard Lendlease Plus points awarding mechanism, with applicable daily cap limit as well as prevailing Terms and Conditions.

- g. For collection of prizes, the top spenders must produce his/her NRIC/passport and mobile number (or flash the unique QR ID from Lendlease Plus member's mobile app) for verification purposes. All prizes must be claimed within the stipulated period at B1 Concierge Desk.
- h. If there is any discrepancy between the documents produced for verification, the entry shall be deemed as disqualified.
- i. The Management reserve the right to replace the Top Spenders if he/she is found to be disqualified and will not be responsible for the loss of opportunity to participate.
