General Terms and Conditions

- iii. Spend receipt(s) used for participation in the Promotion must be of purchases made by the shopper personally, and of minimum S\$10 in nett value each.

- v. In meeting the minimum spend requirement, persons are NOT allowed to use prepaid cards, as a form of top-up.
