


1 Good For Earth 27 Sep – 31 Oct 2021

- 1.1 Promotion period is from 27 Sep – 31 Oct 2021 (both dates inclusive), while stocks last.
- 1.2 Lendlease Plus members who have purchased eco- friendly merchandises from any stores at Paya Lebar Quarter, from 27 Sep – 31 Oct 2021, are eligible to redeem bonus Lendlease Plus\$.

- 1.3 To qualify for the redemption, members are required to present the original receipts and eco- friendly merchandises at PLQ Mall Basement 1 Concierge Desk (last redemption at 9.30pm) for verification.
- 1.4 Eco- friendly merchandises refer to:
- Items which can be recycled or reused in the long run.
 - Items have to be made of sustainable, plastic-free or zero waste materials.

**Eco-friendly merchandises are not limited to the list above and will be subjected to Concierge review on a case-by-case basis.*

- 1.6 Redemption is limited to the first 500 Lendlease Plus Members throughout the promotion period, on a first-come first-served basis, while stocks last.
- 1.7 One (1) redemption per Lendlease Plus member throughout the promotion period.
- 1.8 Redemption must be made on the same day as purchase and is limited to three (3) items per redemption per Lendlease Plus member.

- 1.9 Approved receipts scanned via the Lendlease Plus mobile app will not be qualified for redemption.
- 1.10 The bonus Lendlease Plus\$ is awarded in addition to the daily cap e.g \$10,000 Plus\$ for Basic members and 20,000 Plus\$ for Premium members.
- 1.11 Promotion is mutually exclusive from other rewards redemptions, i.e. Receipts used to qualify for this rewards redemption cannot be re-used to qualify for other rewards redemption from 27 Sep – 31 Oct 2021.

- 2.2 Lendlease Plus members are eligible to redeem a complimentary Lendlease recycle bag.
- 2.3 Redemption is only available at the Concierge desks of 313@somerset, Jem, Parkway Parade and PLQ Mall (last redemption at 9.30pm)
- 2.4 Redemption is limited to the first 250 Lendlease Plus members per mall throughout the promotion period, on a first-come first-served basis, while stocks last.
- 2.5 One (1) redemption per Lendlease Plus member throughout the promotion period.
- 2.6 All other standard terms and conditions of the Lendlease Plus Programme apply.
- 2.7 Other Terms of Use apply and further subject to the General Terms and Conditions as set out below.

General Terms and Conditions

- i. Subject to the criteria set out herein, shoppers must be at least sixteen (16) years of age as at the date of participation to qualify for any promotions or redemption events forming part of the Promotion. Lendlease Retail Pte. Ltd. ("The Management") reserves the right to request for proof of age at any time.
- ii. Shoppers who do not have an existing account nor valid Lendlease Plus membership will need to provide your Name, Mobile number, Date of Birth, Gender, Contact Number, Postal Code as well as Email Address to participate in the Promotion.
- iii. Spend receipt(s) used for participation in the Promotion must be of purchases made by the shopper personally.
- iv. All purchases made at retail, food and beverage, entertainment and service outlets at Paya Lebar Quarter are eligible for the Promotion.
- v. In meeting the minimum spend requirement, persons are NOT allowed to use prepaid cards, as a form of top-up. Transactions made at event fairs (by non-PLQ retailers), money-changing facilities, top-up card machines or transactions in connection to the car park, purchases of cash cards/ gift vouchers/ memberships/ insurances/ travellers' cheques/ lottery tickets, payment of bills at any PLQ outlet, and purchase of Lendlease Gift Vouchers and SISTIC tickets from the Concierge Desk are strictly EXCLUDED.
- vi. Notwithstanding the provisions herein, The Management reserves the absolute discretion to determine the eligibility of any person who is interested to participate in the Promotion. Such determination is final and conclusive, and The Management is not obliged to give any reason for disqualifying any person from participating in the Promotion.
- vii. By participating in the Promotion, persons will be deemed to have read, understood and agreed to be bound by these rules and any other requirements set out in any related promotional material and all amendments, additions, replacements, modifications as may be made from time to time.
- viii. Personal information you provide in registering to participate in the Promotions, or otherwise deal with Paya Lebar Quarter or The Management, may be collected and used for several purposes including, but not limited to, analytical purposes, sending you occasional updates for special promotions, announcements & important updates from Paya Lebar Quarter (through any mode from time to time, which shall include without limitation mailers, emails and SMSes), to the extent permitted or required by law or regulation. We will not disclose your personal information to third parties except to affiliated companies and our service providers for related purposes, or as required by law.
- ix. The Management's decision on all matters relating to the Promotion is final, conclusive and binding on all persons. No correspondence will be entertained.
- x. The Management and its authorized agencies shall not be liable for any injury, damage or loss arising out of or in connection with the Promotion, and each participant agrees to

indemnify and hold The Management harmless from and against any and all claim, loss or damage incurred by the participant or by any other party in relation to the Promotion.

- xi. The Management reserves the right to vary these Terms and Conditions herein at any time at its absolute discretion without prior notice.
- xii. In the event of any inconsistency between these Terms and Conditions with any other form of publicity collaterals relating to the Promotion, these Terms and Conditions shall prevail.
- xiii. This Promotion, and these Terms and Conditions are governed by the law of the Republic of Singapore and all participants are subjected to the exclusive jurisdiction of its courts in the determination of any matter or dispute arising in connection therewith.
- xiv. These Terms and Conditions listed are not intended to confer rights by a third party under the Contracts (Rights of Third Parties) Act (Cap.53B) to enforce any provision of these Terms and Conditions.
