

## **So March More at PLQ (24 February 2023 – 26 March 2023)**

### **Terms and Conditions**

#### **1) *LENLEASE PLUS MEMBERS EXCLUSIVE* Much March More 24 February 2023 – 26 March 2023**

- a) Lendlease Plus Members are eligible to redeem one \$10 Lendlease E-Voucher with a minimum nett spend of \$200 in a maximum of 3 same-day receipt at Paya Lebar Quarter. Nett spend refers to the final payment amount of purchase after all discounts, points redemptions, and retailer vouchers/ gift cards redemption.
- b) Lendlease Plus Members can clock their spends by uploading receipts via the Lendlease Plus mobile app. E-Voucher will be credited to their in-app wallet upon approval of qualifying receipt(s) within two (2) working days.

### **General Terms and Conditions**

- iii. Only original receipts are accepted. Credit/debit card slips & NETS transaction slips are not acceptable, unless presented together with corresponding original receipts).
- iv. Nett spend refers to the final payment amount of purchase after all discounts, points redemption and retailer vouchers/gift cards redemption.
- v. Lendlease Plus Members may only earn Lendlease Plus\$ on purchases above the min. spend of S\$10 in a single receipt (Plus\$ are awarded based on the nett purchase value after deduction of discounts at all participating retailers), made by the Member at designated stores within the Malls (a "Qualifying Purchase").
