

**OktoBEERfest at Paya Lebar Quarter (6 October – 5 November 2023)**

**Terms and Conditions**

**1) Oktoberfest Rewards *LENDLEASE PLUS MEMBERS EXCLUSIVE***

6 October – 5 November 2023 (both dates inclusive)

- a) Lendlease Plus Members are eligible to redeem 10,000 Plus\$ with a minimum nett spend of S\$200 in a maximum of 3 same-day receipt at Paya Lebar Quarter. Nett spend refers to the final payment amount of purchase after deduction of all discounts, points redemption, membership credits, gift cards, coupons, and vouchers from Lendlease, retailers, or other external partners.
- b) First 200 redemptions on 24 October 2023 will receive an additional 10,000 Plus\$. Limited to 1 redemption per member.
- c) Lendlease Plus Members can clock their spends by uploading receipts via the Lendlease Plus mobile app. Plus\$ will be credited to their in-app wallet upon approval of qualifying receipt(s) within two (2) working days.
- d) Redemption must be made on the same day as purchase and is limited to one (1) redemption per Lendlease Plus Member per day, regardless of total amount spent.
- e) Limited to first 5,000 redemptions throughout the entire promotion period, on a first-come first-served basis or while stocks last.
- f) Vouchers issued cannot be exchanged for other denominations, cash and other gift prizes/ vouchers.
- g) There is strictly no voiding of receipt(s) uploaded via Lendlease Plus mobile app for re-submission at PLQ Mall L4 Concierge.
- h) All other standard Terms and Conditions of the Lendlease Plus Rewards Programme apply.
- i) All redemptions are further subject to the General Terms and Conditions as set out below.

**2) Live-Sized Beer Pong @ PLQ Parkside**

6 October – 15 October 2023 (both dates inclusive)

- a) First 10 shoppers who dine-in at any of the participating PLQ Parkside retailers on the stipulated date after 6pm is eligible to redeem a game card to play the Live-Sized Beer Pong @ PLQ Parkside (in front of Zing).

Game cards will be redeemable at the respective retailers on the dates stipulated below only:

- b) Redemption of game cards will be at the respective PLQ Parkside retailers store. Limited to first 10 redemptions per retailer, on a first-come first-served and while stocks last basis.

- c) Shoppers are required to present the final same-day receipt to the retailer to redeem the game card, one (1) receipt will only allow redemption of one (1) game card, splitting of bill from the same table is not allowed.
- d) Each game card is entitled to one (1) game play chance on the same-day basis between 7pm and 8pm only (Registration starts at 6.45pm). Any requests for extension of validity or refund will not be entertained. Holding a game card does not imply a guaranteed game play and will be further subject to availability.
- e) Game card will be voided if altered, tampered or damaged. Exchange and/or replacement of game cards will not be available.
- f) Redemption of game card is non-transferable, not for sale or exchange and non-refundable including, but not limited to events outside the management's control; governmental acts, acts of God, riots, strikes, natural disasters, haze or inclement weather (regardless of severity).
- g) Registration for Life-Sized Beer Pong @ PLQ Parkside starts at 6.45pm on a first-come first-serve basis at PLQ Parkside (in front of Zing). Only the first 10 participants with an eligible game card will qualify for the actual game play.
- h) In the event of wet weather where it's deemed that the event is not suitable to be held outdoors, game registration and game play will be held at the sheltered walkway next to Salvo by Pasta Fresca.
- i) Life-Sized Beer Pong @ PLQ Parkside will commence from 7pm to 8pm daily, with a maximum of 10 game plays per day.
- j) Participant with one game card may form a team with no more than 6 members for one game play.
- k) For each game play, participants must play against the staff on-site to win. Each game play has a time limit of up to 5 minutes only, no extension is allowed.

### **How to play?**

Participant and the staff will take turn to throw the ball into the life-sized cups. In order to win the game, Participant must successfully throw in the balls into all six (6) life-sized cups before the staff or within five (5) minutes. Participants will be deemed as losing the game if the balls did not land in all six (6) life-sized cups within five (5) minutes or the staff manage to throw in the ball into all life-sized cups before the participant.

- l) Prize awarded will be one (1) \$20 Lendlease E-Voucher. The E-Voucher will only be awarded to one (1) Lendlease Plus member per game, regardless of the number of participants per game play. The winner is required to provide the name and mobile number used for creation of Lendlease Plus account to the staff. The E-Voucher will be credited to the Lendlease Plus member's account within 7 working days.
- m) All Lendlease E-Vouchers issued are strictly non-refundable, non-exchangeable for physical Lendlease vouchers and/or any other retailers' promotional and/or cash vouchers.
- n) Children under the age of 12 years old must be accompanied by an adult to qualify for the game play. Presentation of student ID and/or Identification card may be requested for verification purposes.
- o) The Management shall not be liable for any risks or medical injuries of any participants that may arise during the game.
- p) Please be careful of your safety and belongings at all times. The Management will not be liable for any damage or loss that you may suffer arising from OktoBEERfest, whether such damage or loss is caused by our negligence or otherwise. For safety purposes, all participants must comply with all rules and regulations set by the game and instructed by the staff onsite. Participants who are unable to adhere to all the rules and regulations will be disqualified from the game.

- q) The Management reserves the right to modify, suspend or cancel this Game in the event that it becomes incapable of running as planned, such as technical failures, bad weather conditions, or any other causes beyond the control of Lendlease Retail, despite the best efforts of Lendlease Retail.
- r) The Management reserves the right to change or amend the Terms and Conditions at any time without prior notice. All other standard terms and conditions of the Lendlease Plus Rewards Programme applies.

### **General Terms and Conditions**

- i. Subject to the criteria set out herein, shoppers must be at least sixteen (16) years of age as at the date of participation to qualify for any promotions or redemption events forming part of the Promotion. Paya Lebar Quarter reserves the right to request for proof of age at any time.
- ii. For redemptions at the L4 Concierge Desk (last redemption 9.30pm), original same-day receipts must be presented to qualify. Back-dated receipt(s) are not permitted for redemptions.
- iii. Only original receipts are accepted. Credit/debit card slips & NETS transaction slips are not acceptable, unless presented together with corresponding original receipts.
- iv. Nett spend refers to the final payment amount of purchase after deduction of all discounts, points redemption, membership credits, gift cards, coupons, and vouchers from Lendlease, retailers, or other external partners.
- v. Receipts less than S\$10 in value are not acceptable for Plus\$ earning.
- vi. There will strictly be no conversion of redeemed Lendlease E-Voucher to physical Lendlease voucher.
- vii. For instalment payments and deposits, only nett amount paid on the same day of redemption is valid.
- viii. Payment made by rebates from credit cards and other card rebates and/or discounts are not accepted for redemption.
- ix. In meeting the minimum spend requirement, persons are NOT allowed to use prepaid cards, as a form of top-up. Transactions made at pushcarts, event fairs (by non-PLQ retailers), money-changing facilities, top-up card machines or transactions in connection to the car park, purchases of cash cards/ gift vouchers/ gift cards/ memberships/ insurances/ travellers' cheques/ lottery tickets, payment of bills at any PLQ outlet, and purchase of Lendlease Gift Vouchers and tickets from the Concierge Desk are strictly EXCLUDED.
- x. Notwithstanding the provisions herein, The Management reserves the absolute discretion to determine the eligibility of any person who is interested to participate in the Promotion. Such determination is final and conclusive, and The Management is not obliged to give any reason for disqualifying any person from participating in the Promotion.
- xi. By participating in the Promotion, persons will be deemed to have read, understood and agreed to be bound by these rules and any other requirements set out in any related promotional material and all amendments, additions, replacements, modifications as may be made from time to time.
- xii. Personal information you provide in registering to participate in the Promotions, or otherwise deal with Paya Lebar Quarter or The Management, may be collected and used for several purposes including, but not limited to, analytical purposes, sending you occasional updates for special promotions, announcements & important updates from Paya Lebar Quarter (through any mode from time to time, which shall include without limitation mailers, emails and SMSes), to the extent permitted or required by law or regulation. We will not disclose your personal information to third parties except to affiliated companies and our service providers for related purposes, or as required by law.
- xiii. The Management's decision on all matters relating to the Promotion is final, conclusive, and binding on all persons. No correspondence will be entertained.

- xiv. Paya Lebar Quarter and The Management make no representation as to the merchantability or quality of the products and services of its tenants. Upon redemption, customers enter a contract with the tenants and disputes shall be resolved directly with them.
- xv. The Management and its authorized agencies shall not be liable for any injury, damage or loss arising out of or in connection with the Promotion, and each participant agrees to indemnify and hold The Management harmless from and against any and all claim, loss or damage incurred by the participant or by any other party in relation to the Promotion.
- xvi. The Management reserves the right to vary these Terms and Conditions herein at any time at its absolute discretion without prior notice.
- xvii. In the event of any inconsistency between these Terms and Conditions with any other form of publicity collaterals relating to the Promotion, these Terms and Conditions shall prevail.
- xviii. In the event of dispute, Management's decision shall be final, and no correspondence will be entertained.
- xix. This Promotion, and these Terms and Conditions are governed by the law of the Republic of Singapore and all participants are subjected to the exclusive jurisdiction of its courts in the determination of any matter or dispute arising in connection therewith.
- xx. These Terms and Conditions listed are not intended to confer rights by a third party under the Contracts (Rights of Third Parties) Act (Cap.53B) to enforce any provision of these Terms and Conditions.
