

## Grab These Offers (“Promotion”) Terms & Conditions

### 1) Weekdays Rewards *LENLEASE PLUS MEMBERS EXCLUSIVE* 9 May – 20 June 2025 (both dates inclusive)

- a. Lendlease Plus Members are eligible to receive 10,000 Plus\$ with a minimum nett spend of **S\$150** on Mondays to Fridays (excluding public holidays) at Paya Lebar Quarter, within a maximum of three (3) combined same-day receipts.
