Terms and Conditions

- 1. LENDLEASE PLUS MEMBERS EXCLUSIVE Y.W.B.I.T Roving Exhibition & Collection Drive 21 June 2 July 2023 (both dates inclusive)
- a. Lendlease Plus Members who deposit their qualifying textiles via the onsite smart vending machine from 21 June to 2 July 2023 between 10am to 10pm (last redemption by 9.30pm) at Paya Lebar Quarter, L1 (PLQ Plaza) will be able to redeem Lendlease Plus\$.
- b. Lendlease Plus Members are required to scan their unique in-app Lendlease Plus membership QR code before depositing their qualifying textiles into the onsite smart vending machine to earn Lendlease Plus\$. To locate the unique Lendlease Plus membership QR code, members can click on 'My QR' on the Home tab in the Lendlease Plus mobile app. Qualifying textiles and awardable Lendlease Plus\$ as follow:

- c. Qualifying textiles deposited must be dry and clean. Only uncontaminated textiles will be accepted.
- d. Awarding of Plus\$ for this collection drive is capped at 50,000 Plus\$ per member per day, regardless of membership tier.
- e. Lendlease may reject textiles at its sole discretion, and such decisions shall be considered final. Unsuitable items deposited into the machine will not qualify from Plus\$ earning.
- f. A summary of Plus\$ earned from qualifying textiles will be displayed on the onsite smart vending machine screen upon validation and successful depository. Plus\$ will be credited to member's inapp wallet within 24 hours.
- g. All Plus\$ earned based on the successful depository shall be considered final and is not open to appeal and review on any grounds.
- h. All deposits of textiles are final and conclusive. Strictly no return of item(s) once it has been deposited.
- i. First 150 Lendlease Plus Members who deposit qualifying textiles will receive an exclusive Lendlease tote bag. Limited to one (1) redemption per member and while stocks last.
- j. All other standard Terms and Conditions of the Lendlease Plus Programme apply.
- k. All redemptions are further subject to the General Terms & Conditions as set out below.

2. Shop for Bonus Rewards LENDLEASE PLUS MEMBERS EXCLUSIVE

5 June – 2 July 2023 (both dates inclusive)

- a. Lendlease Plus Members are eligible to receive 10,000 Plus\$ with a minimum nett spend of \$200 at Paya Lebar Quarter, within a maximum of three (3) combined same-day receipts.
- b. Nett spend refers to the final payment amount of purchase after all discounts, points redemption, external vouchers/ coupons, and retailer vouchers/ membership credits/ gift cards redemption.
- c. Limited to the first 5,000 redemptions throughout the Promotion period, on a first-come first-served basis or while stocks last.
- d. Limited to one (1) redemption per member per day regardless of total amount spent.
- e. Members can clock their spends by uploading receipts via the Lendlease Plus mobile app. Plus\$ will be credited to their in-app wallet upon approval of qualifying receipts within 2 working days.
- f. Redemption must be made on the same day as spend.
- g. All other standard Terms and Conditions of the Lendlease Plus Rewards Programme apply.
- h. All redemptions are further subject to the General Terms and Conditions as set out below.

General Terms and Conditions

- i. Subject to the criteria set out herein, shoppers must be at least sixteen (16) years of age as at the date of participation to qualify for any promotions or redemption events forming part of the Promotion. Paya Lebar Quarter reserves the right to request for proof of age at any time.
- ii. All redemptions are valid for Lendlease Plus members only.
- iii. For redemptions at the PLQ Mall L4 Concierge Desk (last redemption at 9.30pm), original sameday receipts must be presented to qualify. Back-dated receipt(s) are not permitted for redemptions.
- iv. Only original receipts are accepted. Credit/debit card slips & NETS transaction slips are not acceptable, unless presented together with corresponding original receipts).
- v. Nett spend refers to the final payment amount of purchase after all discounts, points redemptions, retailer vouchers, coupons, and gift cards redemption.
- vi. Lendlease Plus Members may only earn Lendlease Plus\$ on purchases above the min. spend of S\$10 in a single receipt (Plus\$ are awarded based on the nett purchase value after deduction of all discounts, vouchers and coupons at all participating retailers), made by the Member at designated stores within the Malls (a "Qualifying Purchase"). For purchases of goods and services made by instalments or any form of Buy Now Pay Later plans, Members may only earn Lendlease Plus\$ (or redeem any Rewards) based on the nett amount actually paid on the same day as reflected in the relevant receipt. Any purchases or transactions made at non-designated stores will be considered "Disqualified Transactions" and no Lendlease Plus\$ will be awarded for such transactions.
- vii. There will strictly be no conversion of redeemed E-Voucher to physical Voucher.
- viii. For instalment payments, deposits and trade-in products, only nett amount paid on the same day of redemption is valid.
- ix. Payment made by rebates from credit cards and other card rebates and/or discounts are not accepted for redemption.
- x. In meeting the minimum spend requirement, persons are NOT allowed to use prepaid cards, as a form of top-up. Transactions made at pushcarts, event fairs (by non-PLQ retailers), money-changing facilities, top-up card machines or transactions in connection to the car park, purchases of cash cards/ gift vouchers/ gift cards/ memberships/ insurances/ travellers' cheques/ lottery tickets, payment of bills at any PLQ outlet, and purchase of Lendlease Gift Vouchers and tickets from the Concierge Desk are strictly EXCLUDED.
- xi. Notwithstanding the provisions herein, Lendlease Retail Pte. Ltd ("The Management") reserves the absolute discretion to determine the eligibility of any person who is interested to participate in the Promotion. Such determination is final and conclusive, and The Management is not obliged to give any reason for disqualifying any person from participating in the Promotion.
- xii. By participating in the Promotion, persons will be deemed to have read, understood and agreed to be bound by these rules and any other requirements set out in any related promotional material and all amendments, additions, replacements, modifications as may be made from time to time.

- xiii. Personal information you provide in registering to participate in the Promotions, or otherwise deal with Paya Lebar Quarter or The Management, may be collected and used for several purposes including, but not limited to, analytical purposes, sending you occasional updates for special promotions, announcements & important updates from Paya Lebar Quarter (through any mode from time to time, which shall include without limitation mailers, emails and SMSes), to the extent permitted or required by law or regulation. We will not disclose your personal information to third parties except to affiliated companies and our service providers for related purposes, or as required by law.
- xiv. The Management's decision on all matters relating to the Promotion is final, conclusive and binding on all persons. No correspondence will be entertained.
- xv. Paya Lebar Quarter and The Management make no representation as to the merchantability or quality of the products and services of its tenants. Upon redemption, customers enter a contract with the tenants and disputes shall be resolved directly with them.
- xvi. The Management and its authorized agencies shall not be liable for any injury, damage or loss arising out of or in connection with the Promotion, and each participant agrees to indemnify and hold The Management harmless from and against any and all claim, loss or damage incurred by the participant or by any other party in relation to the Promotion.
